### ASSIGNMENT

AND, New Frontiers HEREBY further covenants that New Frontiers has the full right to convey the interest assigned by this Assignment, New Frontiers will take all action and execute all documents necessary to perfect the interest assigned hereby, and New Frontiers has not executed and will not execute any agreement in conflict with this Assignment;

AND, New Frontiers HEREBY further covenants and agrees that New Frontiers, through its officers and employees, will, without further consideration, communicate with Invisaflo, its successors and assigns, any facts known to New Frontiers and its officers and employees respecting the invention and testify in any legal proceeding, sign all lawful papers when called upon to do so, execute and deliver all papers that may be necessary or desirable to perfect the title to the invention in Invisaflo, its successors and assigns, execute all divisional, continuation, and reissue applications, make all rightful oaths, and generally do everything possible to aid Invisaflo, its successors and assigns, to obtain and enforce proper patent protection for the invention in the United States and

any foreign country, it being understood that any expense incident to the execution of such papers shall be borne by Invisaflo, its successors and assigns.
