Patent Assignment

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00), and other good and valuable consideration to it in hand paid, the receipt and sufficiency of which is hereby acknowledged, Flexible Medical does hereby irrevocably assign, sell, transfer, convey and set over to the Company, free and clear of all liabilities, liens, encumbrances, claims, security interests, licenses and any other restrictions or obligations, the full and exclusive right, title and interest in and to (i) the patents and patent applications set forth in Schedule A hereto, (ii) any applications for patents on any inventions or designs described in any such patents or applications, and all patent applications relating thereto which have been or shall be filed in the United States, its territorial possessions and/or any foreign countries, (iii) any and all applications claiming the benefit of the filing date or claiming priority, directly or indirectly, from any of the foregoing, including without limitation any and all non-provisional applications, divisional applications, continuation applications, continuation-in-part applications, reissue applications, reexaminations, extensions and corresponding international, regional, national and other foreign applications, (iv) any and all patents issuing or reissuing, directly or indirectly, from any of the foregoing, and (v) all claims for damages or injunctive relief by reason of infringement of any of the foregoing, with the right to sue for past infringement and to collect damages for the same for its own use and benefit and for the use and benefit of its successors, assigns and other legal representatives (all of the foregoing hereafter referred to collectively as the "Subject Property").

AND, Flexible Medical hereby confirms and acknowledges that the Company shall have sole and absolute discretion with respect to filing, prosecution, maintaining and enforcement of the Subject Property.

AND, Flexible Medical shall promptly transfer to the Company all files related to the Subject Property.

AND, Flexible Medical does hereby authorize and requests that patents issued from any of the foregoing patent applications be issued to the Company, as the assignee of the entire right, title and interest thereto.

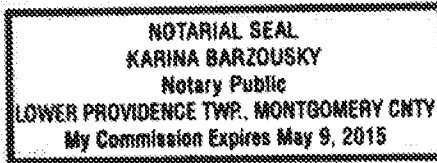

AND, Flexible Medical hereby represents and warrants that (i) Flexible Medical has the sole and unrestricted right to assign the Subject Property to the Company, free and clear of all liabilities, liens, encumbrances, claims, security interests, licenses or other restrictions or obligations, (ii) Flexible Medical has not previously assigned or otherwise transferred its rights in the Subject Property, (iii) Flexible Medical has full power and authority to enter into this Agreement, (iv) this Agreement does not and will not violate any existing agreement to which Flexible Medical is subject or a party, nor will the assignment of the Subject Property to The Company pursuant to this Agreement deprive any third party of any rights to which such third party is entitled, and (v) there are no pending or threatened lawsuits, proceedings, claims, governmental actions or investigations against Flexible Medical which could, in any manner, adversely effect the rights granted or reduce the value of the rights granted to the Company in this Agreement.
