

SAIC-Frederick, Inc. ("the Corporation"), a corporation organized and existing under the law of the State of Delaware, hereby certifies as follows:

1. The name of the Corporation is SAIC-Frederick, Inc.
2. The Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware under the name SAIC-Frederick, Inc. on June 27, 2000 (the "Certificate of Incorporation").
