GeoEye Analytics Inc. ("Corporation"), a corporation organized and existing under the laws of the State of Delaware, pursuant to Section 242 of the General Corporation Law of the State of Delaware ("DGCL"), hereby certifies as follows:

FIRST: The name of the Corporation is GeoEye Analytics Inc.

SECOND: The Corporation was incorporated under the name SPADAC INC and its original Certificate of Incorporation was filed with the Delaware Secretary of State on February 22, 2007. The Corporation filed an Amended and Restated Certificate of Incorporation through a Certificate of Merger with such office on December 15, 2010, changing its name to GeoEye Analytics Inc.

THIRD: The amendment of the Amended and Restated Certificate of Incorporation set forth herein has been duly adopted by the Board of Directors of the Corporation pursuant to Sections 141(f) and 242 of the DGCL and has been, in lieu of a meeting of stockholders, consented to in writing by the sole stockholder of the outstanding stock of the Corporation in accordance with Section 228 of the DGCL.

FOURTH: Article First of the Amended and Restated Certificate of Incorporation is hereby amended as follows:


"The name of the Corporation is DigitalGlobe Intelligence Solutions, Inc."
