## Assignment – Patent rights

### Parties:

- (1) **The Assignor:** William Graham Bell, of P O Box 336, Stafford, ST17 0JL

### Recitals:

- 1.1 In pursuance of said agreement and in consideration of the sum of £10 (ten pounds) now paid by the Assignee to the Assignor (the receipt whereof the Assignor hereby acknowledges) the Assignor with full title guarantee **HEREBY ASSIGNS** to the Assignee the Patent/s and Application/s including the right title and interest therein and all the rights, privileges and immunities conferred on the proprietor or applicant thereof (including the right to claim priority) free from all encumbrances and including the right to sue for damages and other remedies in respect of any infringement that may have occurred prior to the date of this assignment, to hold unto the Assignee absolutely.
- 1.2 The Assignor hereby covenants with the Assignee that it shall at any time hereafter at the direction and expense of the Assignee execute any document or do any act or thing which the Assignee may consider reasonably necessary or desirable to give effect to this assignment and to register the Assignee or any successor in title thereof as proprietor of the Patent/s and Application/s.




