Gentlemen:

This office represents a group working with Norm Martucci. The purpose of this communication is to provide notice that you have breached the HydraQuip Agreement with Mr. Martucci by failing to provide payments, breaching your fiduciary duties, abandonment of the manufacturing facility leaving HydraQuip in breach of its lease, and other various nefarious acts that grossly prejudice Mr. Martucci.

Based on this continuing breach and your failure to communicate with Mr. Martucci, we consider your prior Agreement null and void, and all IP rights under the Agreement will revert to Mr. Martucci.
