## ASSIGNMENT

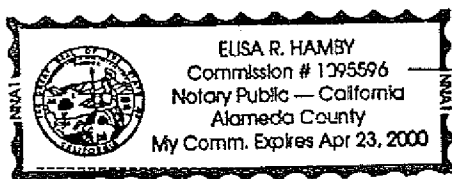

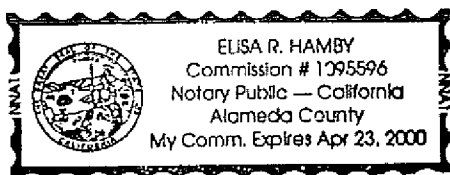
