**TERMINATION AND RELEASE OF SECURITY INTEREST
IN PATENT AND TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of May 6th, 2010, from Northwest Venture Partners III, L.P., as Collateral Agent (the "Agent") for certain investors, to Vigilos, Inc., a Washington corporation ("Company").

WITNESSETH:

WHEREAS, the Agent and Vigilos are parties to that certain Security Agreement, dated as of August 18, 2009 (the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, Vigilos granted to the Agent a security interest in all of Vigilos' assets (the "Collateral" and the "Security Interest", respectively); and

WHEREAS, the Parties now agree that it is in the best interests of the Agent, the secured parties, and Vigilos for the Collateral to be sold to a third party;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Release of Security Interest. The Agent hereby irrevocably terminates, releases and discharges its Security Interest in the all of Company's right, title and interest of every kind and nature as of the date hereof in the patents and trademarks that were Collateral (as defined in the Security Agreement), including, without limitation, those items listed on Schedule A hereto (the "IP Collateral"), and any right, title or interest of the Agent in such IP Collateral hereby ceases and becomes void.

2. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby. Furthermore, Agent hereby irrevocably designates and appoints Boulder River Holdings, LLC, a purchaser of certain of the Collateral, and/or any of its authorized officers and agents as Agent's agent and attorney in fact, coupled with an interest, to act for and on Agent's behalf and in Agent's stead to execute and file any document needed to effect the termination, release and discharge of the Security Interest, and to do all other lawfully permitted acts to further such termination, release and discharge, with the same legal force and effect as if executed by Agent itself.
