ASSIGNMENT OF INTELLECTUAL PROPERTY RIGHTS

THIS ASSIGNMENT OF INTELLECTUAL PROPERTY RIGHTS ("Assignment") is made and entered into as of September 9, 2005 ("Effective Date") by and between Synergio AG, having an address at Vordergasse 3, CH 8201 Schaffhausen, Switzerland ("Assignor") and Dr. Jan Otto Solem, an individual with an address at Erlenwisenstrasse 25, CH 8234 Stetten, Switzerland ("Inventor") and Edwards Lifesciences AG, a company organized and existing under the laws of Switzerland, having a principal place of business at Au Glapin, 1162 Saint Prex, Switzerland ("Assignee").

WHEREAS, Inventor has invented certain new and useful improvements for which an application for a Swedish Patent was filed in Sweden on April 21, 2005, entitled "A BLOOD FLOW CONTROLLING APPARATUS," and was assigned Swedish Patent Application Number 0500891-7 ("Swedish Patent Application"); and

WHEREAS, Assignor warrants itself to be the owner of the interest in the invention and Swedish Patent Application herein assigned and to have the right to make this Assignment; and further warrants that there are no outstanding prior assignments, licenses, or other rights in the interest herein assigned; and

WHEREAS pursuant to this Assignment, Assignor wishes to assign to Assignee, and Assignee wishes to obtain from Assignor interest in said invention and Swedish Patent Application.

Now therefore, in consideration of 20,000 CHF (Swiss Francs) and other good and valuable consideration, the receipt and sufficiency whereof are hereby acknowledged, Assignor hereby conveys, transfers and assigns to Assignee, its successors, legal representatives and assigns, the entire right, title and interest throughout the world in the above-mentioned invention and improvements, in the above-mentioned application for Swedish Patent, and any and all other applications in Sweden and in any other countries which may be filed, either solely or jointly with others, on said invention or improvements, and in any and all issued patents of any country which may be obtained on any of said applications, and in any reissue, reexam or extension thereof.

Assignor hereby authorizes and requests the Swedish Patent Office to issue said Swedish Patent to said Edwards Lifesciences AG.

For said consideration Assignor and Inventor hereby agree, upon the request and at the expense of said Assignee, its successors, legal representatives and assigns, to execute any and all additional Swedish patent applications for said invention or improvements, and any necessary oath or supplemental oath or affidavit relating hereto, and any application for the reissue, re-exam or extension of any issued patent that may be granted upon said Swedish Patent Application that said Assignee, its successors, legal representatives and assigns may deem necessary or expedient. Assignor and Inventor further agree to perform, upon such request, any and all affirmative acts to obtain Swedish Patent, and vest all rights therein hereby conveyed in said Assignee, its successors, legal representatives and assigns whereby said Swedish Patent will be held and enjoyed by said Assignee, its successors, legal representatives and assigns to the end of the term for which said Swedish Patent may be granted as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment and sale had not been made, including the right to enforce said patent and to sue for and recover damages and all other remedies arising out of any and all past, present and future infringement or violation of said Swedish Patent, and for said considerations Assignor and Inventor hereby also assign to said Assignee, its successors, legal representatives and assigns the entire rights, title and interest in said invention or improvements for any and all other countries, including the United States, and the right of priority for patent and utility model applications in any and all countries arising

under any applicable international convention for the protection of industrial property and/or any internal priority legislation of such countries, and Assignor and Inventor further agree upon the request of said Assignee, its successors, legal representatives and assigns to execute any and all documents that shall be required to be executed in connection with applications for patents therefore in any and all other countries, including the United States, and to execute any and all documents necessary to invest title in said applications and patents in said Assignee.
