

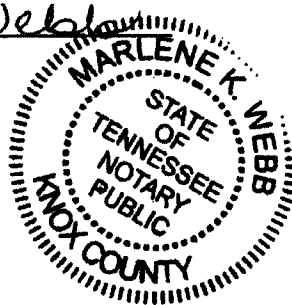

CERTIFICATE AND ARTICLES OF MERGER OF FILMAX, INC. AND FILMAX, LLC

Pursuant to the provisions of Tennessee Code Annotated §§48-249-702 and 48-21-107, this Certificate and Articles of Merger is being filed by the undersigned in the Office of the Secretary of State of Tennessee in order to merge **Filmax, Inc.**, a Tennessee corporation, and **Filmax, LLC**, a Tennessee limited liability company.

1. The name and jurisdiction of each of the constituent parties to the merger are **Filmax, Inc.**, a Tennessee corporation (the "Corporation"), and **Filmax, LLC**, a Tennessee limited liability company (the "LLC").

2. The name of the limited liability company is **Filmax, LLC**. The date of filing of its Articles of Organization with the Tennessee Secretary of State was April 4, 2012.

3. The name of the corporation is **Filmax, Inc.** The date of filing of its Charter with the Tennessee Secretary of State was September 7, 1984.

4. An Agreement and Plan of Merger has been approved and executed by the unanimous approval of the members of the LLC on April 4, 2012 and by the unanimous approval of the shareholders and Board of Directors of the Corporation on April 4, 2012, which satisfies the required percentage of all of the votes entitled to be cast.
