Pursuant to Title 6, Section 18-209 of the Delaware Limited Liability Act (the "LLC Act"), the undersigned, LiveClips LLC, a Delaware limited liability company (the "Company"), hereby certifies as follows:

FIRST: The name and state of formation of each of the constituent limited liability companies of the merger (the "Constituent LLCs") are as follows:

THIRD: The Company shall be the surviving limited liability company (the "Surviving Company") in the Merger, and the name of the Surviving Company in the Merger is "LiveClips LLC".

FOURTH: Upon the filing of this Certificate of Merger, the Certificate of Formation of the Surviving Company shall be the Certificate of Formation of the Company as in effect immediately prior to the consummation of the Merger.
