ASSIGNMENT OF PATENT RIGHTS

WHEREAS, the undersigned, Kollmorgen AB, (formerly known as "Atlas Copco Controls Aktiebolag" and "Danaher Motion Stockholm AB") a Swedish Corporation having a business address at Solkraftsvagen 13, SE-135 70 Stockholm, Sweden presently holds title and all rights to United States Patent Applications 12/545,156 (now issued patent 7,948,276), 13/020,481 (now issued patent 8,598,835), 13/159,743 and 13/850,051, 10/540,820 (now issued patent 7,471,534), 13/308,477 (now issued patent 8,558,490), 08/554,276 (now issued patent 5,715,141) and to the inventions described in these applications;

WHEREAS, Inmotion Technologies AB (hereinafter "Assignee") a Swedish Corporation having a business address at Solkraftsvagen 13, SE-135 70 Stockholm, Sweden is desirous of obtaining the entire right, title and interest in, to and under said applications and said inventions;

NOW, THEREFORE, in consideration of good and valuable consideration acknowledged by Assignor to have been received in full from said Assignee, Assignor confirms the following:

1. Assignor has sold, assigned, transferred and conveyed unto said Assignee the entire right, title and interest (a) in and to the above-listed United States Patent Applications and to the inventions described in these applications; (b) in and to all rights to apply for foreign patents on based upon said patent applications pursuant to the International Convention for the Protection of Industrial Property or otherwise; (c) in and to any and all applications filed and any and all patents granted on said inventions in the United States or any foreign country (including rights to all past and future damages arising from infringement of these patents), including each and every application filed and each and every patent granted on any application which is a divisional, substitution, continuation, or continuation-in-part of any of said applications; and (d) in and to each and every reissue or extension of any of said patents.

2. Assignor agrees to cooperate with Assignee to enable Assignee to enjoy to the fullest extent the right, title and interest herein conveyed in the United States and foreign countries. Such cooperation by said Assignor shall include prompt production of pertinent facts and documents, giving of testimony, execution of petitions, oaths, specifications, declarations or other papers, and other assistance all to the extent deemed necessary or desirable by said Assignee (a) for perfecting in said Assignee the right, title and interest herein conveyed; (b) for prosecuting any of said applications; (c) for filing and prosecuting substitute, divisional, continuing or additional applications covering said inventions; (d) for filing and prosecuting applications for reissuance of any said patents; (e) for interference or other priority proceedings involving said inventions; and (f) for legal proceedings involving said inventions and any applications therefor and any patents granted thereon, including without limitation reissues and reexaminations, opposition proceedings, cancellation proceedings, priority contests, public use proceedings, infringement actions and court actions; provided, however, that the expense incurred by said Inventors in providing such cooperation shall be paid for by said Assignee.

3. The terms and covenants of this assignment shall inure to the benefit of said Assignee, its successors, assigns and other legal representatives, and shall be binding upon Assignor, Assignor's legal representatives and assigns.

4. Assignor hereby warrants and represents that Assignor has not entered and will not enter into any assignment, contract, or understanding in conflict herewith.
