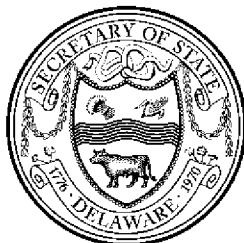

Rhodia Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware,

DOES HEREBY CERTIFY:

FIRST: That the Board of Directors of said Corporation, adopted a resolution by the unanimous written consent of its members, filed with the minutes of the Board, approving the following amendment to the Certificate of Incorporation of said Corporation. The resolution setting forth said amendment is as follows:

RESOLVED, that the Certificate of Incorporation of the Corporation be amended by changing Article 1 thereof so that, as amended, said Article shall read, in its entirety, as follows:

"1. The name of the corporation is Solvay USA Inc.; and be it further"

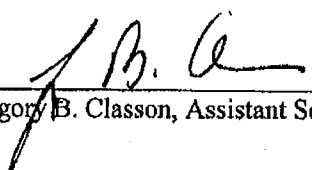

FOURTH: This Certificate of Amendment shall be effective as of October 1, 2013.
