UNITED STATES PATENT ASSIGNMENT

Pursuant to the Agreement, which is incorporated by reference as if fully set forth herein, the Assignors hereby assign to the Assignee all of Assignors' right, title and interest in and to the Patents including all proceeds therefrom and the right to bring an action at law or in equity for any infringement, dilution or violation of any of the Patents occurring prior to the date hereof, and to collect all damages, settlements and proceeds relating to the Patents.

2. This Patent Assignment may be executed simultaneously in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

3. This Patent Assignment is subject to all the terms and conditions of the Agreement. The Parties intend that this Patent Assignment is for recordation purposes only and its terms shall not modify the applicable terms and conditions of the Agreement, which govern the Parties' rights and interests in the Patents.

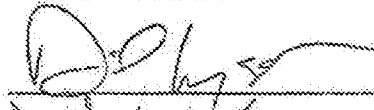

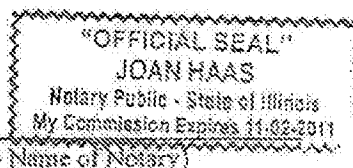
