RELEASE OF SECURITY INTEREST IN

Collateral Agent agrees to execute and deliver such further instruments and take or cause to be taken such other or further action as Grantor may reasonably request, and at Grantor's sole cost and expense, in order to perfect, confirm or evidence such release.
