**(General Laws Chapter 156D, Section 10.06; 950 CMR 113.34)**

LTX-Credence Corporation, having a registered office at 155 Federal Street, Boston, MA 02110 (the "Corporation"), certifies as follows:

FIRST, ARTICLE 1 of the Restated Articles of Organization of the Corporation are affected by these Articles of Amendment (this "Amendment").
