

And I do hereby authorize and request the Commissioner of Patents of the United States and the Patent Office officials in countries foreign to the United States to issue said Patent to **Sealed Air Corporation (US)**, as the assigns of my entire right, title, and interest in, to, and under the same, and I hereby further authorize said **Sealed Air Corporation (US)** to apply for Letters Patent in my name or in its own name, as it in its sole discretion sees fit, utilizing any benefits which may exist under any International Arrangement, in any country foreign to the United States.

And I do hereby agree for myself and for my heirs, executors, and administrators to execute any lawful document and to testify as to any material fact or thing which **Sealed Air Corporation (US)** its successors and assigns may deem necessary in order to secure unto itself, its successors and assigns the full right, title, and interest in and to and the full enjoyment of said invention or any part therefor and the said Patent or any of them, the same to be done without any further consideration.
