Figure 5 is a right side view thereof;

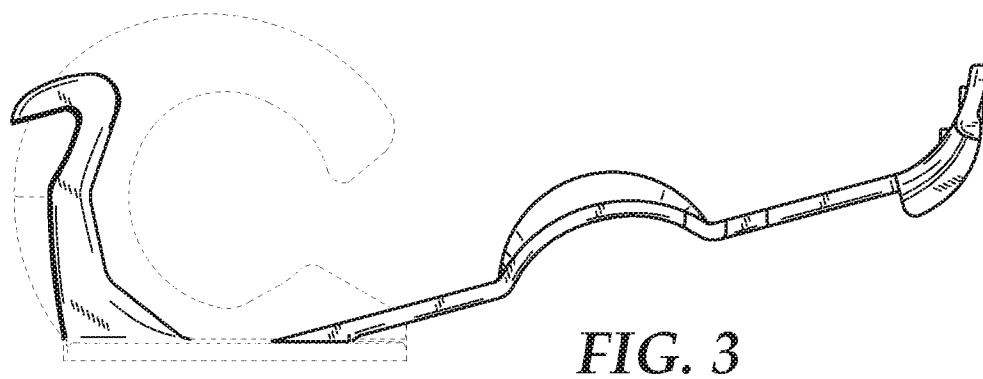
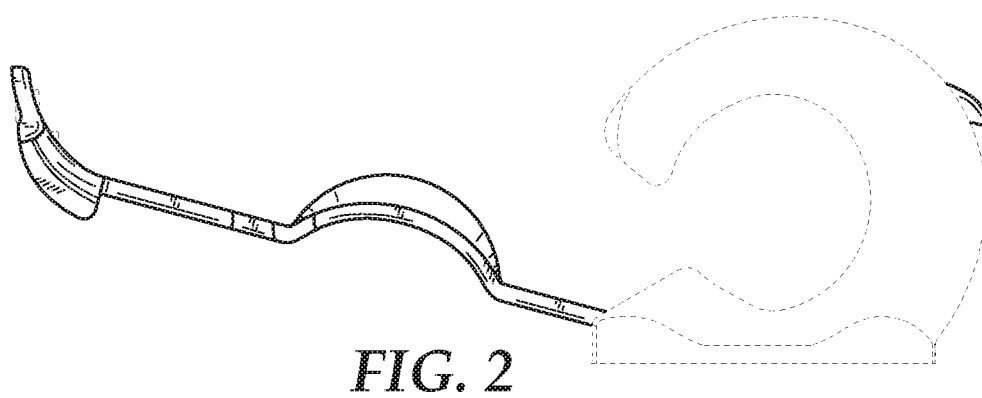
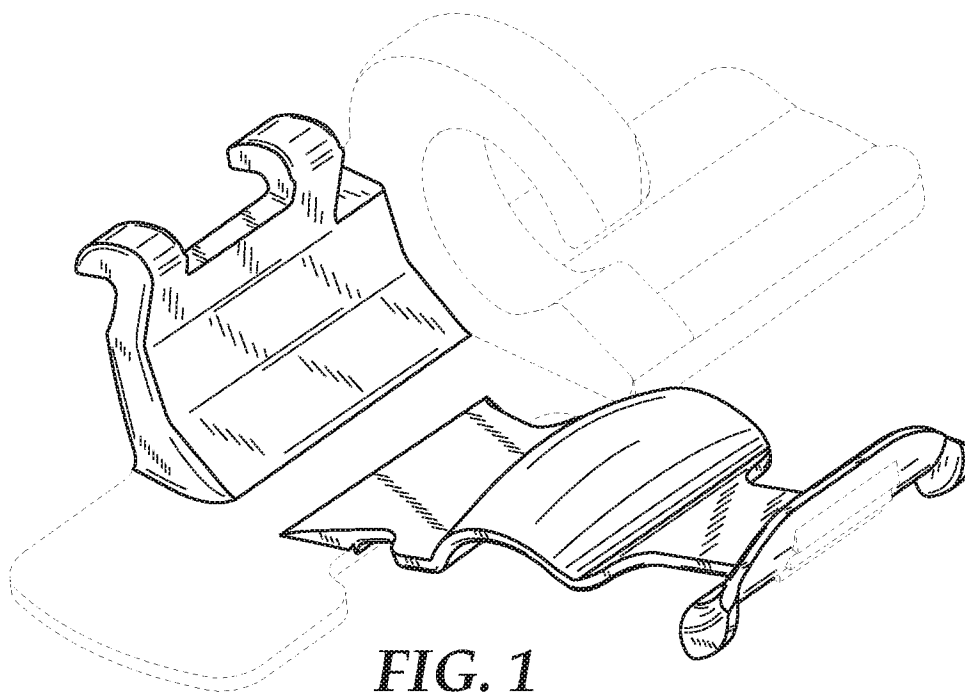
Figure 6 is a bottom view thereof; and

The ornamental design for a Securement Device as shown and described.



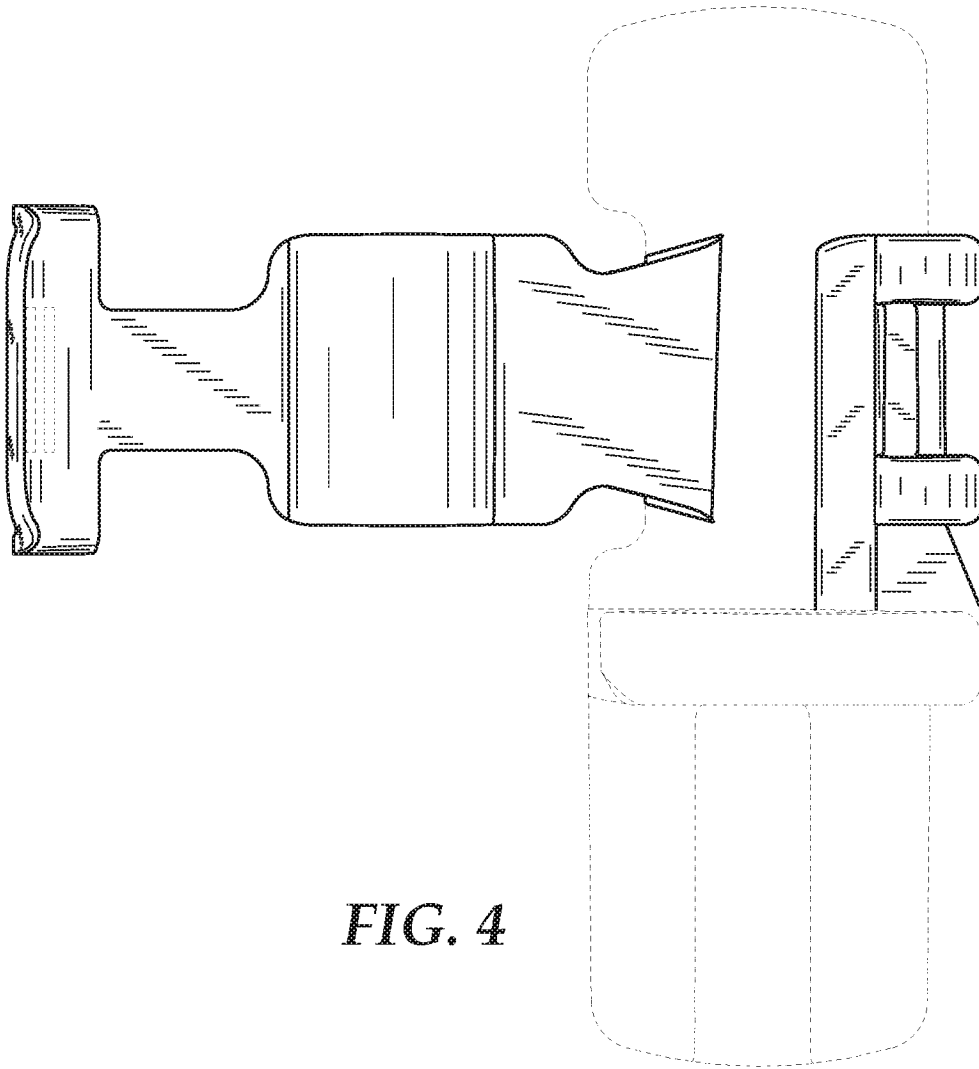

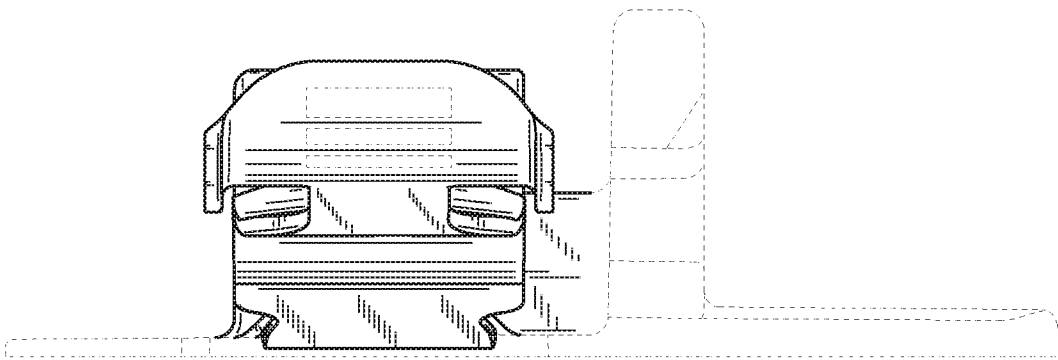
