ASSIGNMENT

WHEREAS, certain improvement in Oil Sands Solvent Extraction processes for which application papers for United States Patent thereon have been filed, described and claimed in U.S. Patent Application no. 11/249,234, filed on 10/12/2005, now U.S. Patent no. 7,909,989 granted on 3/22/2011, entitled METHOD FOR OBTAINING BITUMEN FROM TAR SANDS,


