ASSIGNMENT

Assignors hereby acknowledge that at the time of making the improvements herein identified, Assignor was under an obligation to assign to Assignee, Assignor's entire right, title and interest in, to and under said improvements;

Assignors hereby covenant that Assignor has full right to convey the interest herein assigned, and that Assignors have not executed, and will not execute, any agreement in conflict herewith and that Assignee, Northrop Grumman Systems Corporation, its successors, assigns and other legal representatives shall have the right to hold and enjoy for its and their own use and benefit, to the end of the term or terms for which such Letters Patent shall or may be granted, reissued or extended as fully and completely as the same right could have been held and enjoyed by Assignors had this Assignment not been made.

Assignors hereby further covenant and agree to communicate to Assignee, its successors, legal representatives and assigns, any and all facts known to Assignor respecting said improvements; to promptly provide Assignee with all documents relating to said improvements, said invention, and said Letters Patent as may be known or accessible to Assignors; to testify as to the same in any interference or litigation or other legal proceedings related thereto; to sign all lawful papers, execute all extensions, continuations, continuations-in-part, divisional and reissue applications; and to make all rightful oaths or declarations and generally do everything possible to aid Assignee, its successors, legal representatives and assigns in obtaining and enforcing all the rights herein conveyed for said improvements in all

countries without further compensation, but at the expense of Assignee, its successors, legal representatives and assigns.



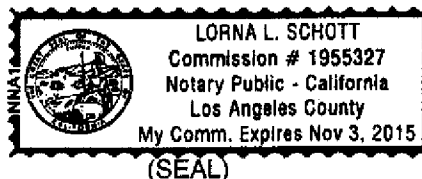


