in and to all the rights to sue for and collect damages resulting from past, present and future infringement of all granted or to be granted Patents;

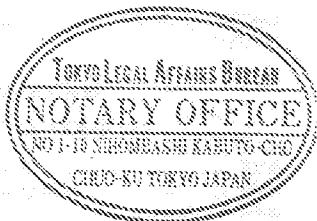

authorized by all necessary action on the part of the ASSIGNOR, and no other authorization or proceedings on the part of the ASSIGNOR are necessary to authorize this Assignment. This Assignment has been duly executed and delivered and constitutes a valid, binding and enforceable assignment of the entire right, title, and interest in the patents and Applications, and Inventions disclosed therein.

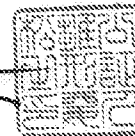
