SELL, ASSIGN, TRANSFER and CONVEY to ASSIGNEE, and ASSIGNEE hereby accepts and assumes, the whole and entire right, title and interest for the United States and its possessions and territories and all foreign countries in and to the inventions disclosed in the patent applications and patents identified in Exhibit A, and, in and to any and all patents and patent applications identified in Exhibit A, but not limited to, all provisionals, non-provisionals, divisionals, continuations, continuations-in-part, substitutes, reexaminations, reissues and all other applications for patent which have been or shall be filed in the United States and all foreign countries on the inventions; all original, reissued and reexamined patents and extensions thereof which have been or shall be issued in the United States and all foreign countries on the inventions to the full end of the term or terms for which the patent(s) may be granted, as fully and entirely as the same would have been held by the undersigned ASSIGNOR had this Assignment not been made; and specifically including all rights of priority created by the above patent applications under any treaty, convention or law relating thereto. Said Assignment includes, without limitation, all income, royalties, damages or payments due or payable after the date of this Assignment related to any of the foregoing and all claims for damages by reason of past, present or future infringement or other unauthorized use of the foregoing, with the right to sue for and collect the same;

AUTHORIZE and REQUEST the issuing authority to issue any and all United States and foreign patents granted on the invention to ASSIGNEE, and to record this Assignment so as to reflect ASSIGNEE's ownership of the patents and patent applications;

WARRANT and REPRESENT that no assignment, grant, mortgage, license or other agreement affecting the rights and property herein conveyed has been or will be made to others by ASSIGNOR, and that the full right to convey the same as herein expressed is possessed by ASSIGNOR; and

AGREE and UNDERTAKE, when requested and at the expense of ASSIGNEE, to carry out in good faith the intent and purpose of this Assignment. ASSIGNOR will execute all non-provisionals, divisionals, continuations, continuations-in-part, substitutes, reexaminations, reissues, and all other patent applications on the inventions; execute all lawful oaths, declarations, assignments, powers of attorney and other papers; communicate to ASSIGNEE all facts known to ASSIGNOR relating to the inventions and the history thereof; and generally do everything possible which ASSIGNEE shall consider desirable for vesting title to the inventions in ASSIGNEE, and for securing, maintaining and enforcing proper patent protection for the inventions; all without further compensation to ASSIGNOR.

THIS ASSIGNMENT IS BINDING on the heirs, assigns, representatives and successors of ASSIGNOR and extending to the successors, assigns, and nominees of ASSIGNEE.

THIS ASSIGNMENT shall constitute the entire agreement between the parties with respect to the subject matter of this Assignment and supersede all prior agreements and understandings, both oral and written, between the parties with respect to the subject matter of this Assignment.

THIS ASSIGNMENT shall be governed by and construed in accordance with the laws of the State of Delaware, without giving effect to conflicts of law principles thereof.
