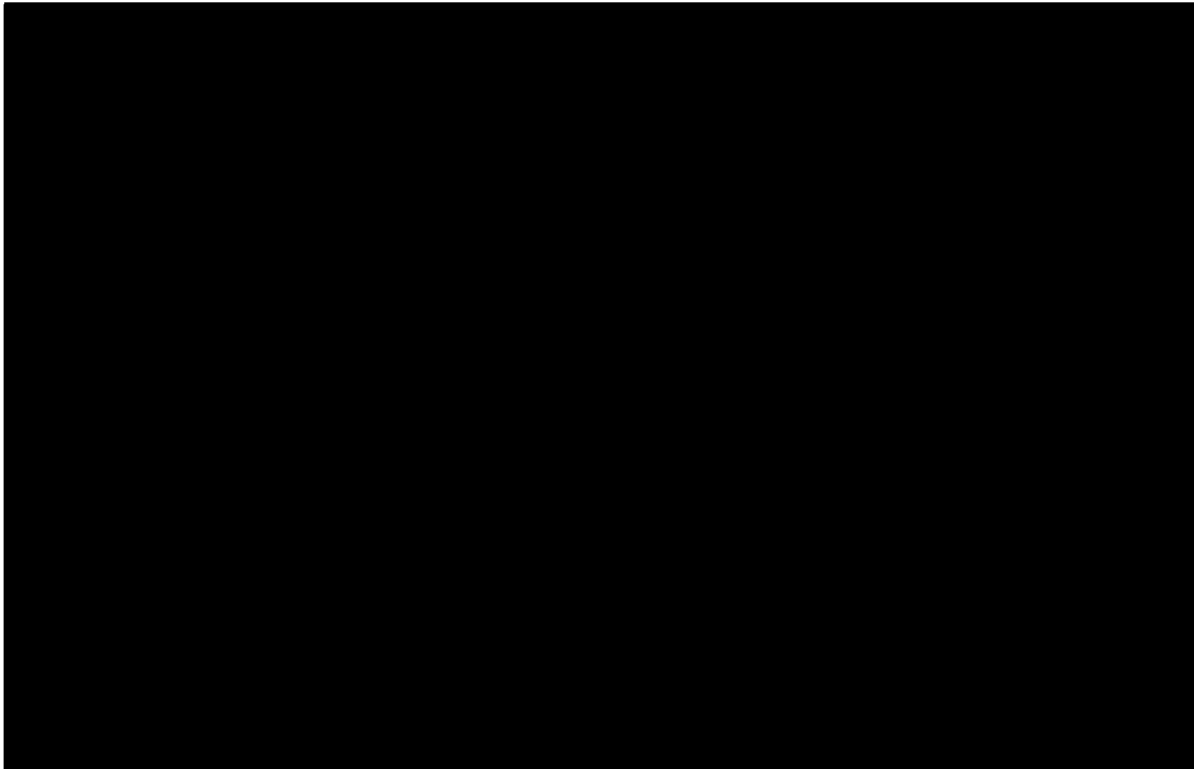

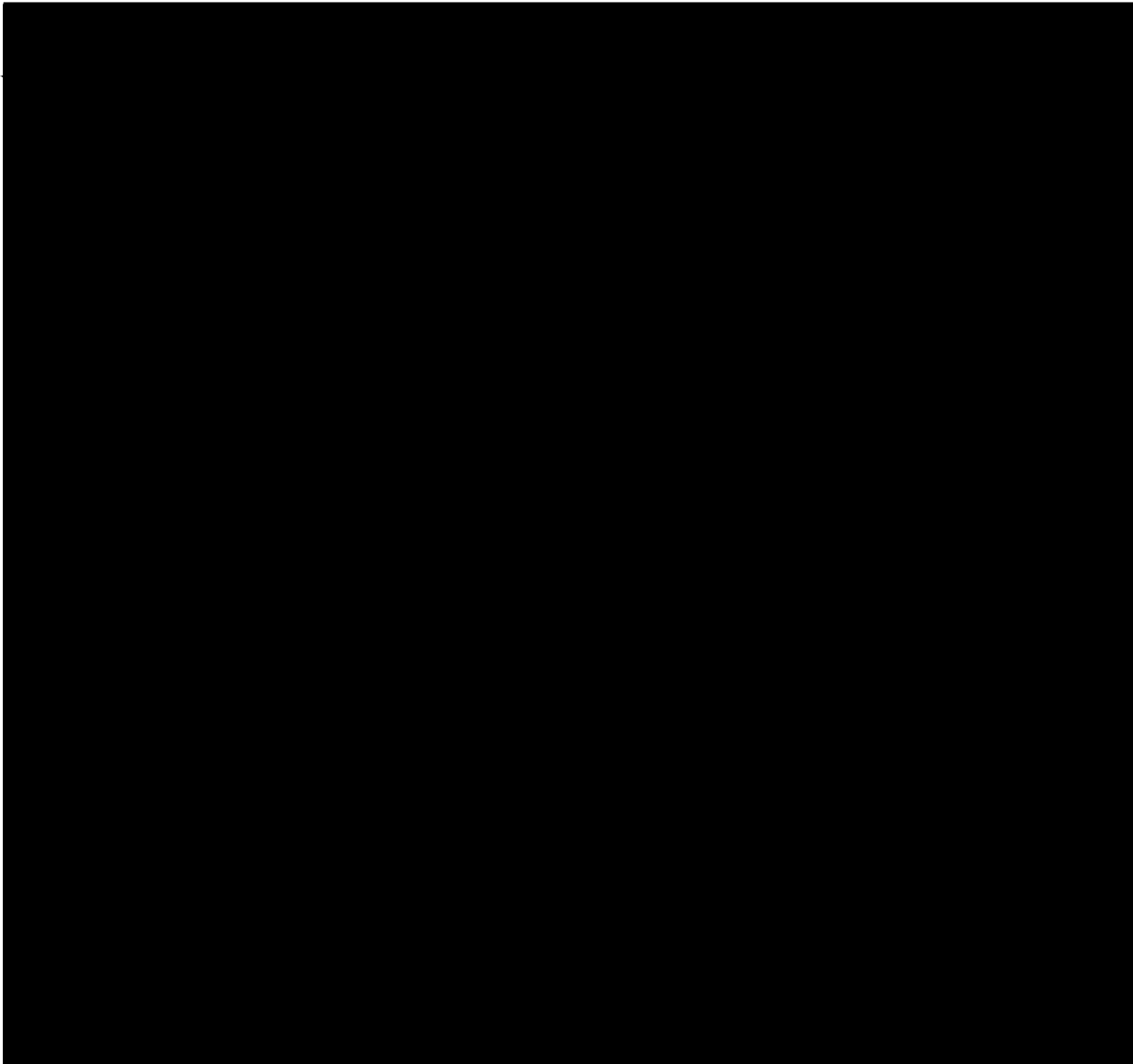
Confidentiality and Non-Compete Agreement

Effective Date: January 4, 2013

This agreement is between "the company", Gill Metal Fab, dba Moduline Aluminum Cabinets, a corporation in the state of Massachusetts, and Jason Borden, who will hereafter be referred to as "employee."
