## ASSIGNMENT

WHEREAS We, Yasuhiro Ikegami and Sadahiro Hara (hereinafter referred to as "ASSIGNOR") of c/o YANMAR CO., LTD., 1-9, Tsurunochō, Kita-ku, Osaka-shi, Osaka 530-8311 Japan have invented certain new and useful improvements in:

### ROTATION POSITION DETECTION MECHANISM FOR TRUNNION AXIS
