SELL, ASSIGN AND TRANSFER to HzO, Inc., a Delaware corporation, having a place of business at 12637 South 265 West, Draper, Utah 84020, United States ("ASSIGNEE"), the ASSIGNOR's entire right, title and interest for the United States and all other jurisdictions in and to any and all designs and any and all improvements which are disclosed in (i) U.S. Design Patent Application No. 29/493,307, filed on June 6, 2014, and titled "MOBILE TELEPHONE" ("the '307 Design Application"); (ii) any and all designs and improvements disclosed in the '307 Design Application, (the "Improvements"); (iii) all divisional, continuing, substitute, renewal, reissue and all other applications for patent or the legal equivalent thereof which have been or may be filed in the United States and all other jurisdictions relating to any of the Improvements (the "Related Applications"); (iv) all original, reissued, reexamined and reviewed patents or their legal equivalents which have been or shall be issued in the United States and all other jurisdictions on any of the Improvements; and specifically including (v) the right to file applications for patents or their legal equivalents under the provisions of any convention or treaty and claim priority based on the '307 Design Application (all of the foregoing, collectively the "Intellectual Property Rights");

AUTHORIZE the ASSIGNEE to apply for and receive any and all patents or their legal equivalents in any jurisdiction relating to any of the Improvements in its own name;

AUTHORIZE AND REQUEST the issuing authority to issue any and all patents or their legal equivalents granted in any jurisdiction for any of the Improvements to and in the name of the ASSIGNEE;



generally to do everything possible which the ASSIGNEE shall consider desirable for vesting title to such Improvements, the '307 Design Application and all of the other Intellectual Property Rights in the ASSIGNEE, and to secure, maintain, defend and enforce valid and enforceable patent protection for the Improvements, the '307 Design Application and all of the other Intellectual Property Rights;

AGREE AND ACKNOWLEDGE that the SALE, ASSIGNMENT AND TRANSFER of rights and property set forth herein is and shall be IRREVOCABLE and BINDING upon the heirs, assigns, representatives and successors of each undersigned ASSIGNOR and EXTEND to the successors, assigns and nominees of the ASSIGNEE.
