SECURITY INTEREST 1

WHEREAS, **Tyme, Inc.** ("GRANTOR"), having a place of business at 2711 Centerville Road, Suite 400, Wilmington, Delaware 19808, owns one or more inventions disclosed, described and/or claimed in the application entitled "**Pharmaceutical Compositions and Methods**" ("the invention"), which is referred to as Docket No. 101444.000003, U.S. Appl. No. **13/371,076**, filed **February 10, 2012** ("the subject application") (now U.S. Patent No. **8,481,498**, issued **July 9, 2013**), which claims the benefit of U.S. Provisional Appln. No. 61/587,420, filed January 17, 2012.

AND, WHEREAS, **Crone Kline Rinde LLP**, as Collateral Agent ("GRANTEE"), having a place of business at 488 Madison Avenue, 12th Floor, New York, New York 10022, is desirous of obtaining a Security Interest in the invention.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the GRANTOR hereby grants to the GRANTEE, its successors, legal representatives, and assigns, a Security Interest in all of GRANTOR's right, title, and interest in the invention, and all applications for industrial property protection, including without limitation, all applications for patents, utility models, inventors' certificates, and designs that have been filed, and that may hereafter be filed, in any country, that disclose, describe, and/or claim the invention, including, without limitation, the subject application and the priority application, and all extensions, renewals, and reissues of such applications, including all divisions and continuations in whole or in part; all patents granted on such applications in any country, and all extensions, renewals, and reissues of such patents, including all divisions and continuations in whole or in part; the right to file such applications in any country; and the right to claim for such applications in any country the priority rights derived from the priority application and the subject application under the International Convention for the Protection of Industrial Property, the Patent Laws of the United States, any other international agreement or protection, or the domestic laws of any country in which any such application is filed, as may be applicable.

GRANTOR hereby covenants and agrees that it has full right to convey said Security Interest, and that it has not executed, and will not execute, any agreement in conflict herewith.


Upon the occurrence and during the continuation of any Security Interest Event of Default, the GRANTEE shall be entitled to exercise all rights and remedies of a secured party upon default under the Uniform Commercial Code with respect to the invention, in addition to which the GRANTEE may sell, license, assign, transfer, or otherwise dispose of the invention in any manner, in whole or in part, as the GRANTEE may determine in its sole and absolute discretion.
