ASSIGNMENT

ASSIGNMENT made by Alan Saghatelian of 92A Brattle Street, Cambridge, MA 02138 (hereinafter the ASSIGNOR) to President and Fellows of Harvard College, a corporation organized under the laws of the State of Massachusetts, and located and doing business at 17 Quincy Street, Cambridge, MA 02138, (hereinafter the ASSIGNEE).

For good and valuable consideration provided by ASSIGNEE to ASSIGNOR, the receipt of which is hereby acknowledged by ASSIGNOR:

The ASSIGNOR sells, assigns and transfers to the ASSIGNEE and its successors and assigns his entire right, title and interest in the invention entitled **ALPHA/BETA-POLYPEPTIDE ANALOGS OF GLUCAGON-LIKE PEPTIDE-1** which was filed in the U.S. Patent and Trademark Office on June 23, 2014, and assigned serial number 14/312,081 which claims priority to U.S. Provisional Patent application serial number 61/838,300 which was filed on June 23, 2013, including, without limitation, the right to bring legal action to enforce said patent and retain any benefit resulting from such enforcement for infringements occurring prior to the date of this assignment.

This sale and assignment extends to the application and any related substitute, refile, divisional, or continuation applications filed in the United States and elsewhere; any subsequent patent applications filed in the United States or elsewhere claiming the benefit of priority to this or any of the aforementioned applications; any patents issuing out of any of the aforementioned applications, and any reissues or extensions of such patents; and any other patent applications or patents relating to the invention set forth in the application identified above.

The ASSIGNOR covenants that he has the full right to convey his entire right, title and interest in the invention to the ASSIGNEE, and that he has not executed and will not execute any agreement in conflict with this ASSIGNMENT.

The ASSIGNOR covenants that he will at any time and upon request execute and deliver any and all papers that may be necessary or desirable to perfect the title in the invention, or the title in any application regarding the invention or in Letters Patent that may be granted for the invention. If the ASSIGNEE or its successors or assigns desire to make substitute, refile, divisional, or continuation applications for the invention, or to secure a reissue or extension of a Letters Patent for the invention, or to file a disclaimer relating to the invention, or to make an application for a corresponding patent in any foreign country, the ASSIGNOR covenants that he will at any time and upon request sign all papers, make all rightful oaths, and do all lawful acts necessary for these purposes, but at the expense of the ASSIGNEE.

The ASSIGNOR acknowledges that his entire beneficial interest in the invention to which the above application relates is irrevocably vested in the ASSIGNEE, including the right

to apply for protection in all countries abroad and the right to claim priority under any International Conventions for such applications, and assent to the making of any such applications and any substitutes, refiles, divisionals, or continuations resulting from any such applications, with or without priority claims.

The ASSIGNOR covenants that he will at all times communicate to the ASSIGNEE, its successors, assigns, and legal representatives, all facts relating to the invention and any applications or Letters Patent relating to the invention known to them, and testify as to these facts in interferences or other litigation when requested to do so, but at the expense of the ASSIGNEE.
