2. DESCRIPTION OF THE GOODS BEING SOLD:

The Seller agrees to sell to the Buyer all remaining inventory discussed previously at \$58.00 each, the name JB Rebounder to sell the two products JB Rebounder and The Don Ed Arc Trainer. The Seller also releases the rights of the patent of the holder of the patent so that the Buyer may use the product and name for selling these products.

Seller agrees to furnish the original patent documents to Buyer at the execution of this document and that patent shall become the sole property of the Buyer.

There are two molds currently at the Duncast Company, owned by JB Rebounder and these will be included in the sale.

The Seller guarantees that he is the true and lawful owner of the above described Goods and that it is free of all encumbrances, liens, and any and all legal claims.

The Buyer admits having inspected the Goods to his satisfaction and that no guarantees or warranties were expressed or implied by the Seller or his agent regarding the condition, quality, or fitness for any purpose of the Goods.

The Seller also agrees to a non-compete agreement for a period of five (5) years from the executed date of this contract.

The risk passes to the Buyer once the Buyer or his agent takes possession of the Goods.

3. THE PURCHASE PRICE: the sum of \$60,000.00 (sixty-thousand dollars) in three (3) installments

\$25,000.00 (twenty-five thousand dollars) made payable to Jack Brown and Patricia Brown for first installment.

\$25,000.00 (twenty-five thousand dollars) January 1, 2015 for second installment.

\$10,000.00 (ten thousand dollars) January 1, 2016 for final installment.

The Buyer also agrees to pay shipping costs for the inventory.....price to be determined.
