Assignment

WHEREAS, **SolarWorld Innovations GmbH**, a German corporation having a principal place of business at Berthelsdorfer Str. 11A, 09599 Freiberg/Saxony, Germany ("SWIN") is the sole and exclusive owner of the single patent **US 7807544 B2** (SWIN ID: PARC 09 US 2, PARC ID: 20060988-US-DIV-2) (called the "Patent"); and

SWIN does hereby irrevocably and perpetually assign, convey, and transfer to PARC, all right, title and interest throughout the world, in and to the Patent, all of which are to be held and enjoyed by PARC for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, to the end of the term or terms for which the Patent are or may be granted, reissued or extended as fully and entirely as the same would have been held and enjoyed by SWIN, if this assignment and sale had not been made; together with all causes of action (whether known or unknown or whether currently pending, filed, or otherwise) and other enforcement rights under, or on account of, any of the Patent, including, without limitation, all causes of action and other enforcement rights for (i) damages, (ii) injunctive relief, and (iii) any other remedies of any kind for past, current and future infringement, and all rights to collect royalties or other payments under or on account of the Patents, all for PARC's own use and behalf, and for the use and behalf of its successors, assigns or other legal representatives.

SWIN hereby authorizes and requests the Commissioner of Patents and Trademarks, or an equivalent officer in any jurisdiction in which a Patent may have filed, to issue any and all Letters on said Patent to PARC as assignee of the entire interest, and hereby covenants that SWIN has full right to convey the entire interest herein assigned, and that, except as otherwise explicitly agreed and acknowledged in writing between the parties, SWIN has not executed, and will not execute, any agreements in conflict therewith.
