
ASSIGNMENT

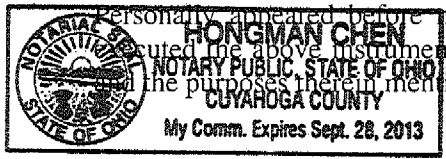



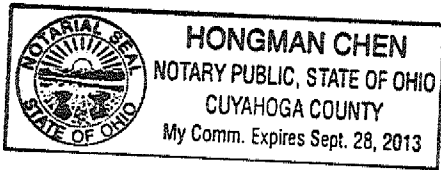
