The undersigned hereby certify and set forth:

FIRST: The name of the constituent entities are Uretex, Inc., a Connecticut Corporation and Uretex Holding LLC, a Connecticut limited liability company.

SECOND: The merger of Uretex, Inc. with and into Uretex Holding LLC will be effective upon the filing of this Certificate of Merger with the Secretary of State of Connecticut.

THIRD: The survivor of the merger is Uretex Holding LLC (hereinafter sometimes referred to as the "Survivor").

FOURTH: The plan of merger by and between Uretex, Inc. and Uretex Holding LLC (the "Plan of Merger") was duly authorized and approved by the sole member of Uretex Holding LLC in accordance with Section 34-194 of the Connecticut Limited Liability Company Act and by the Board of Directors and sole stockholder of Uretex, Inc. in accordance with its organizational documents.

FIFTH: The Articles of Organization of the Survivor are hereby amended to change the name of the Survivor to Uretex LLC.


SIXTH: The Plan of Merger is on file at the place of business of the Survivor at 30 Lenox Street, New Haven, Connecticut 06513.

SEVENTH: A copy of the Plan of Merger will be furnished by the Survivor, on request and without cost, to any person or entity that is a party to the merger.
