## ASSIGNMENT OF INVENTION AND LETTERS PATENT

WHEREAS, we, **Benjamin Bin Chen, Joseph S. Costa, Laurent Abbas and Sri R. Seshadri**, hereinafter referred to as Assignors have invented certain new and useful improvements in **IMPROVED SHELF LIFE OF POLYOL BLENDS CONTAINING HALOGENATED OLEFINS BY ENCAPSULATION OF ACTIVE COMPONENTS**, **USSN 14/374,616**, filed **07/25/2014** for which an application for Letters Patent of the United States has been duly executed by each of us on even date herewith.

And we do hereby request and authorize the Commissioner of Patents, U.S.A., to issue said Letters Patent when granted, in accordance with this assignment.


We further covenant and agree with the assignee that we have a full and






