RELEASE OF PATENT SECURITY AGREEMENT

THIS RELEASE dated as of July 28., 2014 (this "Release") is made by American Capital, Ltd., acting in its capacity as agent (in such capacity, the "Agent") under that certain Patent Security Agreement, dated as of March 12, 2014 (as amended, supplemented or modified and in effect from time to time, the "Patent Security Agreement") by and among Undercover, Inc. WHEREAS, the Grantor has requested and Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Patent Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Patent Security Agreement in the Patent Collateral, (b) release its security interest in the Patent Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to Agent in the Patent Collateral.
