NUNC-PRO-TUNC ASSIGNMENT

FURTHER, ASSIGNOR hereby confirms that, effective as of February 21, 2014, he also transferred his rights to Big Mouth Toys, Inc. to sue and collect damages for any past or present infringement with respect to said Big Mouth Toys Intellectual Property Rights.
