
PATENT APPLICATION ASSIGNMENT

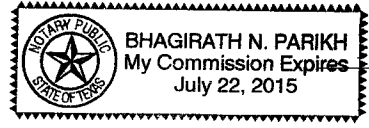


