Subsection 19(4) of the *Canada Business Corporations Act* (CBCA) requires a corporation to send Form 3 to Corporations Canada within 15 days of any change to its registered office address.

If the registered office address changes to another province, this form must be accompanied by Form 4 - Articles of Amendment and the fee of \$200 (paragraph 173(1)(b) and subsection 177(1) of the CBCA).

Item 4

An additional address is useful for a corporation that wants to receive annual return reminder notices and other correspondence from Corporations Canada at an address that is different from its registered office address. If a corporation provides us with an additional address, we will send annual return reminder notices to the additional address instead of to the registered office address.
