## ASSIGNMENT



Now, therefore, to all whom it may concern, be it known that for good and valuable consideration, the receipt of all of which is hereby acknowledged, ProTerra hereby sells, assigns and transfers to Marvel, its successors and assigns, the entire right, title and interest in and to said Patent, including the right to sue for past, present, or future infringements thereof, the same to be held and enjoyed by Marvel for its own use and benefit, and for the use and benefit of its successors and assigns, to the full end of the term for which said Patent was granted, as fully and as entirely as the same might be held by ProTerra had this assignment not been made, and ProTerra represents and warrants that it has not executed and will not execute any instrument inconsistent with the rights granted herein, and ProTerra agrees to execute any and all papers and instruments and to do any and all acts which may be necessary or required by Marvel, in order to carry into full force and effect this sale, assignment and transfer, and ProTerra agrees to communicate at any time, upon request by Marvel, any facts relating to said Patent and the history thereof known to ProTerra, and ProTerra agrees to testify as to the same in any litigation to enforce said Patent when requested to do so by Marvel.
