CONFIRMATORY ASSIGNMENT OF PATENT RIGHTS

WHEREAS United States Surgical Corporation ("USSC"), a Delaware corporation having a place of business at 150 Glover Avenue, Norwalk, Connecticut, has previously conducted business involving the research, design, manufacture, and sale of medical and surgical products (the "Business");

WHEREAS Tyco Healthcare Group LP ("Tyco Healthcare"), a Delaware limited partnership having a place of business at 60 Middletown Avenue, North Haven, Connecticut, currently conducts business involving the research, design, manufacture, and sale of medical and surgical products;

WHEREAS Tyco Healthcare previously operated under the name The Kendall Company Limited Partnership, a Delaware limited partnership ("Kendall");

WHEREAS on April 8, 1999 Kendall filed a change of name certificate in the State of Delaware changing the name of the limited partnership to Tyco Healthcare Group LP;

WHEREAS on April 1, 1999, USSC and Kendall entered into an agreement known as the Contribution Agreement by and between United States Surgical Corporation and The Kendall Company LP ("the Contribution Agreement");

WHEREAS USSC, through the Contribution Agreement, contributed the Business (as defined in the Contribution Agreement) to Kendall, and, in contributing the Business to Kendall, assigned, transferred and delivered to Kendall all of its assets, properties, and business (excepting only the "Excluded Assets," as defined in Section 1.2 of the Contribution Agreement) of every kind and description; wherever located; real, personal, or mixed; tangible or intangible, including, without limitation, all right, title, and interest of USSC in, to, and under patents, inventions and any applications for the same;

WHEREAS as of April 1, 1999 and prior thereto, USSC held all right title and interest in and to the following inventions, and any and all improvements thereof, (hereinafter "the Inventions") which include the invention entitled "Surgical Stapler" which is described in the following patents and/or patent applications ("PATENTS"):

WHEREAS USSC hereby desires to acknowledge that all of USSC's right, title and interest in and to the foregoing Inventions and all Letters Patent pertaining thereto were transferred to Kendall (now Tyco Healthcare) by virtue of the Contribution Agreement; and

WHEREAS USSC desires to ensure that to the extent any of USSC's right, title and interest in the foregoing Inventions and Letters Patent are not deemed transferred from USSC to Tyco Healthcare, that any such past, present, and future rights, title and interest in the foregoing Inventions and Letters Patent be presently assigned to Tyco Healthcare.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

ASSIGNOR: United States Surgical Corporation

Hereby sells, assigns and transfers to

ASSIGNEE: Tyco Healthcare Group LP

And the successors, assigns and legal representatives of the ASSIGNEE any and all rights, title and interest ASSIGNOR may have, if any, including the right to sue for present, past and future infringement, in the United States, its territorial possessions, and in all foreign countries, including all treaty and convention rights, in and to the Inventions, any and all improvements thereto, the PATENTS and any legal equivalent thereof in a foreign country, including any applications, continuations, continuations-in-part, divisions, renewals, reissues, and extensions thereof.
