

I covenant that I have the full right and obligation to convey the interest assigned by this Assignment, and I have not executed and will not execute any agreement in conflict with this Assignment.

I further agree to make, execute and deliver to JANSSEN upon request, any and all papers, documents, declarations, affidavits, or other instruments that may be necessary in the prosecution of any application or applications for the Invention and improvements thereof or reissues of Letters Patent, and to assist JANSSEN in every way as may be requested in protecting said Invention. I acknowledge that this obligation includes the duty to execute, in a timely manner, any Declaration and Power of Attorney that may be necessary in the prosecution of applications relating to said Inventions in the United States or elsewhere.

I agree that this general assignment is effective from 16 December 2010.
