And I further agree to, upon request of ASSIGNEE, (a) promptly provide any and all facts and documents, as may be known and accessible to me, relating to said application and said inventions, (b) testify as to the same in any legal proceeding (including patent office proceedings) related thereto, and (c) generally do all further acts which may be reasonably necessary to obtain and enforce proper patent protection for said inventions in all countries worldwide, provided, however, that the Assignee shall be responsible for all costs and expenses incurred by me with respect to Assignee's efforts to obtain and/or enforce a patent or similar legal protection for said inventions or application;
