Whereas Icon One Incorporated was administratively dissolved by the State of West Virginia on May 21st 2003, the Officers and shareholders unanimously adopt this resolution to recognize the administrative dissolution of the corporation. The resolution further sets forth the following:

A. That at the earliest practicable date, the following will be accomplished:

- (1) Complete liquidation of Icon One Incorporated
- (2) Payment of all corporate debts, if any, and

(3) Facilitate and/or recognize any distribution of any remaining cash, securities, and cash realized from the sale of securities or corporate assets to the stockholders that were due as of the administrative dissolution date of 5/21/2003 and have not yet been received by the shareholders since that date.

B. That the directors and officers of Icon One Incorporated are authorized and directed to immediately initiate the liquidation of the corporation so that assets or the proceeds therefrom not yet distributed can be distributed to its stockholders as soon as possible.

C. That the charter and franchise of Icon One Incorporated will be surrendered and the corporation dissolved in accordance with the administrative dissolution made by the Secretary of State of the State of West Virginia on 5/21/2003.

D. That Icon One Incorporated, which was administratively dissolved many years ago by the Secretary of State of West Virginia will conduct no business except that which is necessary or incidental to liquidation and winding up affairs.

(h) all causes of action (whether known or unknown or whether currently pending, filed, or otherwise) and other enforcement rights under, or on account of, any of the Patents and/or any item in any of the foregoing categories (b) through (g), including, without limitation, all causes of action and other enforcement rights for

- (1) damages,
- (2) injunctive relief, and
- (3) any other remedies of any kind

for past, current, and future infringement; and

(i) all rights to collect royalties and other payments under or on account of any of the Patents and/or any item in any of the foregoing categories (b) through (h).

However, if it is ever determined that Icon One Incorporated owned additional intellectual property at the time of the administrative dissolution, such additional intellectual property is recognized also to have been distributed to the shareholders at the time of the administrative dissolution on 5/21/2003.
