
**IT IS AGREED as follows**

6. This agreement may be executed as a single document or in multiple copies and has effect upon signature by ASSIGNOR.



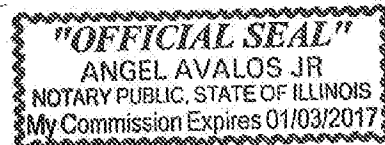

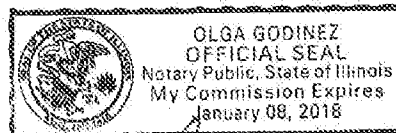
