I hereby represent and warrant that, as far as I am aware, I am the only inventor of the said invention, and that until the time of assignment, sale, transfer or setting over of the invention and of the applications by me to the ASSIGNEE, I was, and have at all times been, the owner of all right, title and interest in and to the invention and of the applications.
