I, RICHARD CHIANG, am the representative of the company "SENSETECH CO., LTD.". The company was established in Taiwan at the beginning, originally using "SENSETECH CO., LTD." as the company's English name, and later using the company name filed patent applications (Serial Nos. 14/200,905 、 14/200,735 and 14/200,804) with the USPTO. Nevertheless, when the company name was registering at the Register Office in Taiwan, the registration request was refused due to an identical prior name registration. For this reason, the name "SENSETECH CO., LTD." has now been changed into "SENSOR TEK CO., LTD." to comply with the requirements for registering a company name in Taiwan. In view of the same, I hereby request the USPTO to change the original company name to "SENSOR TEK Co., Ltd." .
