1.      Nokia Siemens Networks GmbH & Co. KG with registered office in Munich, entered into the Commercial Register of the Local Court of Munich under HRA 88537, as sole limited partner of the company, by the Contribution Agreement of 26 November 2008 has brought its limited partner's share in the company with immediate effect into the sole general partner of the company, Nokia Siemens Networks Vermögensverwaltung Management GmbH with registered office in Munich, entered into the Commercial Register of the local Court of Munich under HRB 172784, and has transferred it to the latter and has therefore withdrawn from the company.
