Change of Articles of Association

I.

As Managing Directors of Nokia Siemens Networks Vermögensverwaltung Management GmbH (the "company") jointly authorised to represent the company, we hereby submit to the Commercial Register:

1. A certified copy of the notarial record of the Shareholders' Meeting of 26 November 2008 (Document Roll No. A 4395/2008 of the Notary Dr. Manfred Asam, Munich) relating to the resolution on the capital increase against a contribution in kind;
2. The full wording of the Articles of Association with certificate pursuant to § 54 Para. 1 p. 2 GmbHG [Limited Liability Companies Act];
3. The notarially authenticated takeover declaration of the sole shareholder Nokia Siemens Networks GmbH & Co. KG;
4. A list of the transferee of the new company share;
5. The Contribution Agreement which was concluded for implementing the contribution in kind; and
6. A confirmation from PricewaterhouseCoopers Aktiengesellschaft Wirtschaftsprüfungsgesellschaft of 24 November 2008 of the value of the limited partner's share transferred to Nokia Siemens Networks Vermögensverwaltung GmbH & Co. KG with Registered Office in Munich, entered into the Commercial Register of the Local Court of Munich under HRA 91983;

II.

We apply for entry into the Commercial register of the following:

1. The company's share capital has been increased by EUR 50.00, from EUR 25,000.00 to EUR 25,050.00 against a contribution in kind.

§ 7 Para. 1 of the Articles of Association has been rewritten as follows:

"The company's share capital is EUR 25,050.00 (in words: twenty-five thousand and five hundred [Translator's note: should read "fifty"?]). It consists of a share of EUR 25,000.00 and a share of EUR 50.00." In addition, § 7 Para. 4 has been changed and Para. 5 deleted.

2. The company's name has been changed.

§ 1 of the Articles of Association has been rewritten as follows:

"The company's name is: Nokia Siemens Networks Vermögensverwaltung GmbH."

The company's business address is: St.-Martin-Straße 76, 81541 Munich.

§ 11 Para. 6 of the Articles of Association has been changed.

III.

We hereby further guarantee that the payment to be made by Nokia Siemens Networks GmbH & Co. KG to the contribution to capital, to the nominal value of EUR 50.00, has been made in accordance with the resolution relating to the capital increase and the transfer declaration and that it is finally at our free disposal to the full amount.

IV.

An amended list of shareholders will be submitted pursuant to § 40 Para. 2 GmbHG by the authenticating Notary immediately after registration and thus the coming into effect of the registered capital increase
