NUNC PRO TUNC ASSIGNMENT OF MFX, INC PATENTS

THIS ASSIGNMENT is made as of the day of June, 2014, by the undersigned now for the recited conditions and circumstances that existed as of January 16, 2009.

WHEREAS, the undersigned MFX, Inc., a Connecticut corporation with an address at 5 River Road, Suite 123, Wilson, CT 06897 (the "Assignor"), owns patent rights to an invention or improvement in four issued design United States patents, Patent Numbers D470,572 dated February 18, 2003, D506,809 dated June 28, 2005, D513,311 dated December 27, 2005 and D516,187 dated February 28, 2006 for an ornamental design for a faucet and plumbing fixture as disclosed in each respective United States Patent; and

WHEREAS the Assignor is dissolving and liquidating its assets, and

WHEREAS Cliff LaMotta ("Creditor") is a creditor of Assignor as evidenced by the Convertible Note Agreement (dated March 24, 2004) and subsequent Promissory Notes #1, 2 & 3 (dated March 30, 2004; January 17, 2006; March 9, 2006 respectively) to the extent of \$150,000 (the "Debt") plus interest as outlined in the agreements; and

WHEREAS Assignor values the Patents at approximately \$1,000.00; and

WHEREAS the Patent constitutes Assignor's major asset and accordingly is distributing and transferring its rights thereto to Creditor, 123 Kesler Drive, Ridgefield, CT 06877.

NOW, THEREFORE, in consideration of the Debt, Assignor hereby sells, assigns, transfers and sets over, unto Creditor, his executors, administrators, successors, legal representatives and assigns all of Assignor's interest in, to and under the said invention, and the applications and all divisional, renewal, substitutions, and continuing applications thereof, and all Letters Patents of the United States of America which may be granted thereon and all reissues and extensions thereof, and all applications for Letters Patent which may be filed for said invention in foreign countries, and all extensions, renewals, reissues thereof, and Assignor hereby authorizes and requests the Commissioner of Patents of the United States of America, and any official of any foreign country whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patents for said invention to Creditor and his executors, administrators, successors, legal representatives and assigns in accordance with the terms of this instrument.
