## ASSIGNMENT



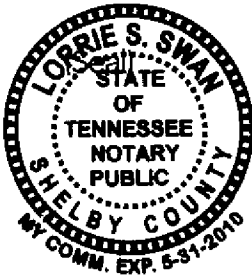
