Assignment – Patent rights

Parties:

- (1) **The Assignor:** William Graham Bell, of P O Box 336, Stafford, ST17 0JL

Recitals:

- 1.2 The Assignor hereby covenants with the Assignee that it shall at any time hereafter at the direction and expense of the Assignee execute any document or do any act or thing which the Assignee may consider reasonably necessary or desirable to give effect to this assignment and to register the Assignee or any successor in title thereof as proprietor of the Patent/s and Application/s.




