**AND THE ASSIGNOR HEREBY** further covenants and agrees that the **ASSIGNOR** will communicate to **ASSIGNEE** any facts known to the **ASSIGNOR** respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute and reissue applications, make all rightful oaths and generally do everything possible to aid **ASSIGNEE** to obtain and enforce proper patent protection for said improvements in all countries.
